CLARIFICATION TEXT REGARDING DATA SUBJECT APPLICATION

Pursuant to the Personal Data Protection Law No. 6698 ("Law"), we hereby inform you, as the data controller, BORENCO, about the processing of your personal data in relation to your requests concerning your rights.

Your personal data will be processed for the purpose of evaluating your request, finalizing it in accordance with the applicable legislation, carrying out the necessary actions in this regard, and storing your personal data in compliance with legal requirements all within the scope of exercising your rights.

In line with the fulfillment of these purposes, your personal data will be processed based on the legal grounds of fulfilling our legal obligations and the establishment, exercise, or protection of a right. Your personal data may be transferred (i) To relevant third parties to whom your personal data has previously been disclosed, limited to the notification required in case you request correction or deletion of your personal data (ii) To authorized public institutions and legally authorized private individuals, where required by law.

As the data subject, you are entitled to the following rights under Article 11 of the Law:

- To learn whether your personal data is being processed,
- To request information if your personal data has been processed,
- To learn the purpose of processing your personal data and whether it is used in accordance with that purpose,
- To know the third parties to whom your personal data has been transferred, either domestically or abroad,
- To request the correction of your personal data if it is incomplete or inaccurate,
- To request the deletion or destruction of your personal data under the conditions set forth in the Law,
- To request that third parties to whom your personal data has been transferred be informed of any corrections made,
- To request that third parties to whom your personal data has been transferred be informed of any deletion or destruction carried out,
- To object to a result that is to your detriment, arising from the analysis of your personal data exclusively through automated systems,
- To request compensation for damages in the event of unlawful processing of your personal data.
