A. WHAT IS A COOKIE?

Cookies are small text files that allow certain information to be stored on your devices such as your phone, computer, or tablet when you visit a website. Cookies enable websites to function efficiently, remember user preferences (such as language selection or site settings), keep the content on websites up to date, carry out personalized marketing activities, and implement improvements for users.

Cookies are divided into three categories according to their intended use, their parties and their duration:

Cookies by Party	
First Party Cookies: First party cookies are created by the website that is being visited.	Third Party Cookies: Third-party cookies are cookies created by other websites.

Cookies by Duration of Use	
Persistent Cookies: Persistent cookies that are not immediately deleted when the web browser is closed; instead, they remain stored on the device and are deleted after a specified period of time.	Session Cookies: Session cookies are used to maintain the continuity of a session and are deleted when the user closes their web browser.

Cookies by Intended Use	
Technical (Mandatory) Cookies: These cookies are necessary for the use of the website. If the use of these cookies is blocked, access to certain parts of the site or all may not be provided.	Performance (Analysis) Cookies: Cookies that collect information about how users use the website. They are used to improve and enhance the user experience.
Marketing Cookies: Used to provide personalized content based on users' interests and to measure the effectiveness of marketing activities cookies.	Functionality Cookies: These cookies are used to remember your usage preferences on the website and to personalize your experience accordingly.

B. COOKIES USED ON THE SITE AND THE LEGAL BASIS FOR THEIR USE

Technical/mandatory cookies, performance/analysis cookies, functionality cookies and marketing cookies are used on the Site. Details of the cookies used on the Site are given below:

In the event that your personal data processed through the cookies used on the Site is transferred abroad, such transfers are carried out in compliance with Article 9 of the Law. In addition, all necessary administrative and technical measures are taken during the transfer of your personal data to foreign countries.

C. PERSONAL DATA PROCESSED THROUGH COOKIES

The following personal data are processed through cookies:

Identity	User ID/ID.
Process security	User activity records, including IP address, browser and operating system, date and time of your visit, interaction status (e.g., whether you were able to access the site or received an error message), usage of site features, search terms entered, frequency of visits, language preferences, scroll behavior on pages, and information about the tabs accessed.

D. COLLECTION OF PERSONAL DATA THROUGH COOKIES

Your personal data mentioned above are collected by automatic methods through cookies. Personal data processing activities carried out through cookies are based on the legal grounds specified under the heading "Legal Grounds for the Use of Cookies".

E. SHARING OF PERSONAL DATA COLLECTED THROUGH COOKIES

Your personal data collected through cookies are shared with third party cookie providers for the purposes and legal reasons specified in this Policy. The sharing of personal data is carried out in compliance with the provisions of Articles 8 and 9 of the Law.

Your personal data are transferred outside Turkey in accordance with the provisions of the Law and the Regulation on the Procedures and Principles Regarding the Transfer of Personal Data Abroad ("Regulation"), which entered into force after being published in the Official Gazette dated 10/7/2024 and numbered 32598. During the transfer of personal data abroad, Borusan and the data recipient party act in accordance with the requirements set forth in Article 9 of the Law and the Regulation, and appropriate safeguards are provided for the transfer of personal data abroad, including the ability of the data subject to exercise his/her rights pursuant to Article 9(4) of the Law and to apply for effective legal remedies in the country of transfer.

F. DISABLING COOKIES

Most browsers offer different ways to protect your privacy. For example, you can allow first-party cookies or block third-party cookies. If you also want to disable the use of all cookies, you can update your browser settings to favor this.
